

## **BIRTHDAY PARTY INFORMATION & WAIVER**

- Set up may begin 30 minutes prior to the start of the party.
- Guest attendees must check in at the Front Desk upon arrival. Party contact should supply staff with this form upon arrival.
- Swimmers must dry off and change clothes before entering the party room.
- No push pins, nails, putty, transparent tape, glue dots, etc. may be used on the walls in the party room. (Only PAINTERS TAPE is allowed).
- Please exit the party room promptly upon the conclusion of your rental time..
- Any swimmers age 5 and under must have a parent/guardian in the water unless they can pass the facility-approved swim test by the lifeguard on duty. Swimmers interested in utilizing the dive tank must also pass the facility-approved swim test before use.
- You may provide your own cake, refreshments, and decorations. We do have a refrigerator on site.
- Any modification to this document or non-signature will result in the cancellation of the event.

## FACILITY USE AGREEMENT AND WAIVER/RELEASE

I and my guests agree to comply with all rules imposed by Aquaventure Winterville Aquatics Campus, (hereafter referred to as "Aquaventure") regarding the use of its facilities and equipment. In consideration of my use of the facilities located at Aquaventure, I hereby, on behalf of myself and my guests, my heirs, executors, administers, successors and assigns, expressly release, discharge and covenant not to sue Aquaventure and its affiliates, insurers, employees, officers, directors, and associates, FROM ALL LIABILITY, CLAIMS, DEMANDS, LOSSES, OR DAMAGES ON MY ACCOUNT CAUSED OR ALLEGED TO BE CAUSED IN WHOLE OR IN PART NY THE NEGLIGENCE OF AQUAVENTURE OR OTHERWISE; AND I FURTHER AGREE that if, despite this AGREEMENT, I, or anyone on my behalf, makes a claim against Aquaventure, I WILL IDENTIFY, SAVE, AND HOLD HARMLESS Aquaventure from any litigation expenses, attorney fees, loss, liability, damage, or cost which any may incur as the result of such claim. By the execution of this agreement, I accept and assume full responsibility for any and all injuries, damages (both economic and non-economic), and losses of any type, which may occur to me and my guests, and I hereby fully and forever release and discharge Aquaventure, its insurers, employees, officers, directors, and associates, from any and all claims, demands, damages, rights of action, or causes of action, present or future, whether the same be known or unknown, anticipated, or unanticipated, resulting from or arising out the use of Aquaventure's facilities.

I understand and agree that Aquaventure Winterville Aquatic Campus is not responsible for property that is lost, stolen, or damaged while in, on, or about the premises.

I understand Aquaventure Winterville Aquatic Campus is not responsible for any food allergies I or my guests may experience while on premises.
